By submitting the below completed and signed form, I hereby acknowledge the following:

On my own behalf and on behalf of my heirs, personal representatives, successors and assigns, for and in consideration of the opportunity to participate in any way in the **Save the Animals Rescue Team** sponsored Ride to Rescue Motorcycle Charity Event which includes a Charity Ride and Charity Rally (herein referred to as "EVENT") sponsored by Save the Animals Rescue Team (hereinafter, S.T.A.R.T.) and their respective Officers, Directors, Employees, Volunteers, Sponsors and Agents (hereinafter, the "RELEASED PARTIES") releases and holds harmless the RELEASED PARTIES from any and all claims and demands, rights and causes of action of any kind whatsoever which I now have or later may have against the RELEASED PARTIES in any way resulting from, arising out of, or in connection with the performance of S.T.A.R.T.'s duties and my participation in the said "EVENT".

I am experienced and familiar with the operation of motorcycles and represent that I understand the nature of a motorcycle run and that I am qualified, in good health, and in proper physical condition to participate in such activity. I am voluntarily participating in the "EVENT" and I expressly agree to assume the entire risk of any accidents or personal injury, including death, which I might sustain to my person and property as a result of my participation in the event, and any negligence (except willful neglect) on the part of any or all of the RELEASED PARTIES in performing their event duties. I further acknowledge that the "EVENT" will be conducted over public roads and facilities open to the public during the "EVENT" and upon which the hazards of traveling are to be expected. I agree to obey all traffic laws and follow safe riding procedures. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the "EVENT". I further agree to cooperate fully with the decisions made by the Ride Director and/or Fundraising Committee where my health and/or safety are deemed in jeopardy due to unsafe conditions of ANY kind.

I give my full permission to S.T.A.R.T., Save the Animals Rescue Team, local affiliates, and their sponsors and corporate partners to publish or sell or otherwise dispose of photographs, videotapes, or other recordings of me that are made during the course of this event. All publicity and advertising rights are reserved by S.T.A.R.T..

I have read and agreed to all conditions of the S.T.A.R.T.'s Charity Motorcycle Event application and to the rules governing the event as set forth on this form, agree to observe all these rules, and agree to abide by the decisions of the event management. If I do not follow all rules of the "EVENT", I understand that I may be removed from the event. By signing this release, I certify that I have read this RELEASE and fully understand it and that I am not relying on any statements or representations by the RELEASED PARTIES.
